## Pure Ground Ingredients Expands Its Minden, NV Operations

Launch of a Foodservice Line and an Online Store Planned for Summer 2019

CARSON CITY, NV – April 9, 2019 – Northern Nevada Development Authority (NNDA) today announced, on behalf of Pure Ground Ingredients (PGI), that the industrial supplier of organic botanicals, spices, chili, and black and green teas has relocated to a larger facility in Minden, NV in order to expand its operations and broaden its product offerings. PGI offers a range of high quality, fair-trade, certified-organic ingredients from all over the globe to customers in North America and Europe who seek organic ingredients for their food, tea and nutraceutical brands.

Later this year, PGI plans to launch a foodservice line focused on serving more local businesses which will available through the company's new online store. The foodservice line will also be available through Distributors of Regional and Organic Produce & Product, or DROPP, the regional food hub of the Reno-based Great Basin Community Food Co-op.

PGI was co-founded by Kevin Lindseth and his sister, Stacy Kixmiller, around their vision of "a world where growers, manufacturers, and consumers all came together in the name of better ingredients, sustainable practices, and a happier, healthier planet." The company has grown from two employees in 2013 to more than fifty employees today. In summer 2018, PGI moved to a 60,000 square foot state-of-the-art facility in Minden, doubling their size and production capacity. The company was recently awarded performance-based state business incentives by the Nevada Governor's Office of Economic Development to support this expansion.

According to PGI's CEO Kevin Lindseth, "When looking to expand, it was important for us to stay close to our previous location in Carson City, so that we could keep our existing workforce and continue to expand. Stacy and I wanted also to be close to our families, and those we consider family, which include our employees. Our team is 100% local, and we want to keep it that way. Douglas County is a great place to be, clear skies, friendly people, and I love being surrounded by the beauty of the mountains and the valley. "

PGI has partnered with local growers for milling, reduced agricultural waste by dehydrating goods extending the usable life of plant-based materials, and donated their organic byproducts for local agricultural feed. In 2018, PGI setup a program to donate organic spices and herbs to Northern Nevada restaurants and non-profits.
